## ISO/TC 37 News



### ISO/TC 37 Standardization activities By teleconferencing, in 2022

Due to the continued Covid-19 pandemic, the Annual Meetings of ISO/TC 37 *Language and terminology* in 2022 again could not take place as onsite meetings.

Work on the following standards taking place in ISO/TC 37/SC 2 resulted in significant new progress:

- **ISO/TC 37/SC 2/JWG 7** *Revision of ISO 639 (joint working group of ISO/TC 37/SC 2 and ISO/TC 46/SC 4)* advanced the revision of ISO 639-4 *Code for the representation of individual languages and language groups – Part 4: General principles, rules and guidelines* to DIS stage.
- **ISO/TC 37/SC 2/WG 1** *Language varieties* largely finalized ISO/DTR 21636 *Description and identification of language varieties* and decided to split up this document into three parts of a new ISO 21636 series under the title *Language Coding — A framework for language varieties*.

Two working groups directly under ISO/TC 37 continued work on:

- ISO/WD 24495-1 *Plain Language — Part 1: Governing Principles and Guidelines* (ISO/TC 37/WG 11) originally initiated by the International Plain Language Federation and officially proposed by Standards Australia (SA)
- ISO/CD 24183 *Technical communication – Vocabulary* (ISO/TC 37/WG 10)

The next ISO meetings are planned to be held online and onsite in Brussels (Belgium), 12-16 June 2023.

## UNESCO:

### IDIL 2022-2032

The International Decade of Indigenous Languages (IDIL 2022-2032) started with a high-level event “Making a decade of action for indigenous languages” in Mexico City, on 28 February 2022. More than 500 participants from 50 countries, including government ministers, indigenous leaders, researchers, public and private partners, and other stakeholders and experts, adopted the Los Pinos Declaration. (See INL 161/162) The Declaration places indigenous peoples at the centre of its recommendations under the slogan “Nothing for us without us.”

The Declaration calls for the implementation of the internationally recognized rights of indigenous peoples, expressed notably in the UN Declaration on the Rights of Indigenous Peoples of 2007, the UN System-wide Action Plan (SWAP) on the Rights of Indigenous Peoples of 2017, and other standard-setting instruments such as UNESCO’s Convention against Discrimination in Education (1960), the UN’s International Convention on the Elimination of All Forms of Racial Discrimination (1965), International Covenant on Civil and Political Rights, and International Covenant on Economic, Social and Cultural Rights (1966).

In addition, a strategic roadmap for the IDIL 2022-2032 was issued prioritizing the empowerment indigenous language users. Current data indicates that at least 40% of the 7,000 languages used worldwide are at some level of endangerment. While reliable figures are hard to come by, experts agree that indigenous languages are particularly vulnerable because many of them are not taught at school or used in the public sphere. More statistical data will become available once UNESCO’s Atlas of Languages, a database about practically all human languages, becomes available later this year.

## UNESCO AI Ethics Recommendation

In November 2021, the 193 Member States of UNESCO adopted the UNESCO [Recommendation on the Ethics of Artificial Intelligence](#). This document is the first global instrument of its kind. It is, according to its preamble, “a standard-setting instrument developed through a global approach, based on international law, focusing on human dignity and human rights, as well as gender equality, social and economic justice and development, physical and mental well-being, diversity, interconnectedness, inclusiveness, and environmental and ecosystem protection”. The Recommendation aims at guiding the development and use of AI technologies in a responsible way, based on universal values and principles.

The aim of this initiative is to raise awareness of the main elements and contributions of this groundbreaking UNESCO Recommendation, as a way to support its implementation. Within the framework of UNESCO's Information for All Program (IFAP) and in close cooperation with the Social and Human Sciences Sector of UNESCO who is responsible for the implementation the instrument, the Info-Ethics working group intends to contribute to the dissemination of the Recommendation, by helping stakeholders to understand its key points. ## Project activities



**EU-Project TRIPS:**  
**TRansport Innovation for disabled People**  
**needs Satisfaction**



Over the last months The TRIPS consortium developed an approach for co-design of solutions for accessible public transport involving major stakeholders and; of course; persons with disabilities. Several workshops were organized under difficult Covid pandemic conditions.

In the framework of the ICCHP-AAATE 2022 – Joint International Conference on Digital Inclusion, Assistive Technology & Accessibility (see p. 5) – several activities related to TRIPS were organized. Besides the TRIPS Project Consortium Meeting, the following expert meetings took place:

- In the session on "Co-Design of Inclusive Public Transportation: The Experience of Users with Disabilities in 7 European Cities" reports were presented on the collaboration of seven European cities to design innovative accessible solutions to boost inclusive mobility.
- In the AAATE/UJTP/ENIL High Level Meeting on "Moving Faster Forward Towards Accessible and Inclusive Public Transport for All" representatives of different European Associations and Authorities discuss how to speed up the process leading to smart, green, and accessible transportation for all.

In conjunction with these activities the ratification ceremony of the LECCO Declaration “Moving faster forward towards Accessible and Inclusive Public Transport for All”, an initiative of three international networks that work together in the TRIPS Project consortium for the sake of making public transport in Europe and worldwide accessible and inclusive, took place. ## EU-Project: LITHME Language In The Human-Machine Era



After LITHME published an [open access report](#) “The Dawn of the Human-Machine Era on 18 May 2021 (see INL 162/162), numerous activities were carried out by the eight working groups of LITHME each focusing on a different key area: 1. Computational Linguistics, 2. Language and law, 3. Language rights, 4. Language diversity, vitality, and endangerment, 5. Language learning and teaching, 6. Ideologies, beliefs, attitudes, 7. Language work, language professionals, and 8. Language variation/change/contact, pragmatics, interaction.

Standardization aspects occur under each of the key areas. (See: [Working groups – LITHME](#)) LITHME runs from October 2020 to October 2024, experts from 39 European countries, 3 COST Near Neighbour Countries and 4 COST International Partner Countries participate. Funding for Short Term Missions (STSM) is available.

#### International Terminology Summer School

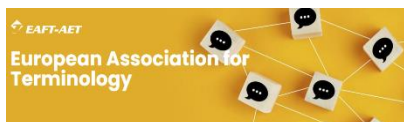


The TSS 2022 took place as hybrid event in Athens (Greece), 1–4 July 2022 organized and web-hosted by the International Network for Terminology (TermNet). Focusing on state-of-the-art knowledge, competences and skills of language service providers (LSP) it focused on

- Understanding terminology management for translation (day 1)
- Terminology management for translation (day 2)
- Terminology for the translation business, tools, costs, legal issues (day 3)
- Case studies and application scenarios (participants’ projects) (day4)

Participation in the TSS qualified to obtain three different international certificates for terminology and translation professionals issued by the European Certification and Qualification Association (ECQA®): ECQA Certified Terminology Manager Basic, ECQA Certified Terminology Manager Advanced, and ECQA Certified Terminology Manager Engineering.

Mr Galinski contributed by providing an overview on various issues concerning intellectual property rights (IPR – especially copyright) related to terminological data and tools.



## EFT – European Association for Terminology

EFT supported the international conference on "Terminology and Specialized Knowledge Representation: New Perspectives on User Needs" organized by the Institute of Croatian Language and Linguistics of Rijeka University, 9/10 June 2022. Mr. Galinski and Ms. Giraldo Pérez presented a paper on "Minimal Interoperability Mechanisms (MIM) Requirements for Terminological and Lexicographical Data. From a 'content interoperability' and 'microcontent' perspective". EFT announced to start publishing the regular publication of "Terminology Science and Research" (TSR) the periodical of the past IITF. A special issue is scheduled to be published online and in open access format in the beginning of 2023

## ICCHP-AAATE 2022



### Joint International Conference on Digital Inclusion, Assistive Technology & Accessibility

The Joint ICCHP-AAATE International Conference 2022 took place 11~15 July 2022 as a hybrid event at the premises of Politecnico di Milano Polo Territoriale di Lecco, in Lecco (Italy). (See: <https://icchp-aaate.org>) It offered a most comprehensive and full experience on Accessibility and Assistive Technologies.

In conjunction with ICCHP-AAATE 2022 several activities related to the TRIPS project were organized (see p. 3). Mr. Galinski presented a paper on "Standards in support of AT & eAccessibility & eInclusion" summarizing the deliverable D13 of the TRIPS project.



## TST 2022

### Institute of Linguistics and Literature of the Mongolian Academy of Sciences

This first international conference on terminology with the theme "Terminology, science and technology development" was originally planned for July 2020 could finally take place as a hybrid conference in Ulaanbaatar (Mongolia), 8/9 July 2022. It was attended by more than 120 participants including high-level political representatives. At the opening ceremony Mr. Galinski gave one of the greeting addresses. In the Conference, he presented a paper on "Cooperation in Terminology. Past, present and future" co-authored by Ms. Giraldo Pérez.

Mongolia, the second largest landlocked country, is bordering on Russia to the North and China to the South and covers an area of 1,564,116 km<sup>2</sup>, with a population of just 3.3 million, making it the world's most sparsely populated sovereign nation. Approximately 30% of the population is nomadic or semi-nomadic. Most citizens (95%) are ethnic Mongols, with roughly 5% of the population being Kazakhs, Tuvans, and other minorities. Since the 1990s urbanization is accelerating to a degree that the capital Ulaanbaatar is nearing fast a population of about 50% of total population. No wonder that most of the country's services industry and educational institutions are concentrated Ulaanbaatar.



Mongolia's education system has undergone colossal changes in the 20th century. With 98% the literacy rate of Mongolian citizens is very high – largely due to a generally high esteem for education. However, students and teachers alike face tremendous challenges to catch up in many fields of sciences and technologies as well as social sciences and humanities. Terminology science and its manifold applications are seen as a key to overcome these challenges. Towards this end, the establishment of a terminology infrastructure to support formal education, vocational training, as well as industry and trade is under discussion.

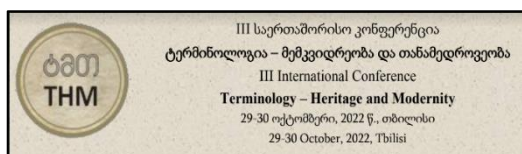
## 23<sup>rd</sup> International Conference on Knowledge Engineering and Knowledge Management

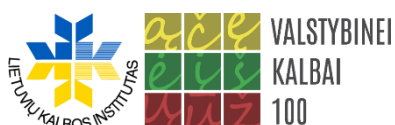
## MDTT 2023 2nd International Conference

The professional responsible for designing and populating terminological resources is the terminographer. Producing new terminological resources requires eclectic research skills. The design and implementation phases involve a thorough preliminary analysis of the information needs of the potential user and an accurate assessment of the structural requirements of the resource. In this context, the second MCTT 2023 aims to bring together specialists in the disciplines of terminology, terminography, computational terminology, specialized lexicography, computational linguistics, NLP, in order to share methodological reflections on design approaches, representation formats and management systems of the digital terminology collected in the terminological resources.

The dictionary *Nomenclatura de gestió universitària (University Management Nomenclature)* is the result of a collaboration between the Xarxa Vives d'Universitats and the TERMCAT Terminology Center, with the aim of disseminating online the work carried out by the Language Commission of the Xarxa Vives through the working group of Terminology and Nomenclature, composed of technicians from the language services of 14 universities in the Network. The fifth edition includes 52 new entries from the 15 sub-areas that already exist and incorporates lexical categories, synonyms, linguistic notes and semantic notes to complete and update the collection as a whole. It is in total, a dictionary with 758 entries at the moment.

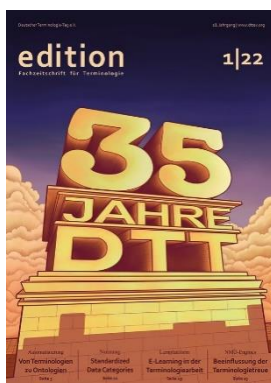

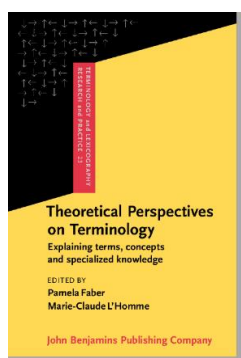

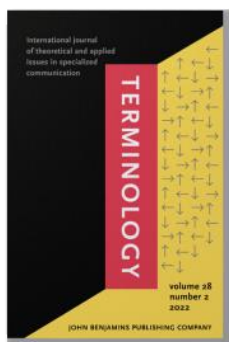

Non-state actors' role extends beyond provision of schooling to interventions at various education levels and influence spheres. Alongside its review of progress towards the UN's Strategic Development Goal SDG 4, including emerging evidence on the COVID-19 pandemic's impact, the 2021/2 Global Education Monitoring Report urges governments to see all institutions, students and teachers as part of a single system.

The report's rallying call – Who chooses? Who loses? – invites policymakers to question relationships with non-state actors in terms of fundamental choices: between equity and freedom of choice; between encouraging initiative and setting standards; between groups of varying means and needs; between immediate commitments under SDG 4 and those to be progressively realized (e.g. post-secondary education); and between education and other social sectors.

The International UNESCO Conference on Technical and Vocational Education and Training (TVET) for Successful and Just Transitions was held virtually from the UNESCO headquarters in Paris, France on 7/8 December 2021. The objective of the conference was to conduct a formal consultation on the new UNESCO Strategy for TVET 2022–29.

The conference included a presentation and discussion of the demand for TVET in the light of the COVID-19 crisis and the major socioeconomic and sustainability challenges, the main line of actions of the new Strategy, together with a set of cross-cutting interventions. The virtual conference drew more than 1,200 participants, with a high of 880 participants during the high-level session.
